5. The Technical bids received shall be opened online on **25-03-2019 (1400 Hrs)** in the office of Chief Engineer PHE Department Jammu.
6. The Financial bids of the bidders shall be opened online in the office of the Chief Engineer PHE Department Jammu.
7. Bids must be uploaded alongwith scanned copy of cost of tender document as specified in column 4 of the table in shape of echallan / copy of receipt from Treasury favouring Executive Engineer, PHE Mech. Procurement Division Jammu by crediting the requisite charges to the MH: 0215 (Revenue Misc.). Similarly scanned copy of the earnest money / bid security in shape of CDR / FDR or Bank Guarantee valid for two years of requisite amount payable at Jammu pledged to Chief Accounts Officer, PHE Department Jammu must be uploaded.
8. After receiving electronic message of financial bid opening, the L1 Bidder shall deposit the Hard copies of the relevant documents in the office of the Chief Engineer PHE Department Jammu during working hours within seven days positively. If L1 bidder fails to submit the original documents / EMD within the prescribed time, the department will cancel the tender and action shall be taken against the bidder to debar/blacklisting in future tendering process in the department which will be decided by the Departmental Purchase Committee.
9. Only reputed manufacturers for supply of ISI Marked Mild Steel ERW Bevelled ended Inside Beed Free Casing Pipe conforming to IS 4270/2001 can participate in the tendering process.
10. The bid for the supply of material shall remain open for acceptance for a period of **180 days** from the date of opening of price bids. If any bidder/tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
